

# RESIDENTS FOR TEMESCAL VALLEY

**We will provide an educational forum for the purpose of preserving, promoting and protecting the Temescal Valley "Sense of Community." We will acknowledge our distinct and historic identity while remaining independent and self-sufficient.**



- **WE BELIEVE** we are an independent, self-sufficient and historic community of interest within the unincorporated area of Riverside County. Our identity has been recognized by the Temescal Heritage Foundation, by the County's Temescal Valley Design Guidelines within its specific plan, by the State through its placement of Temescal Valley entrance and exit signs along the I-15 Freeway, and by the Federal Government's Temescal Valley profile in U.S. Census Bureau data.
- **WE BELIEVE** we have a voice in the planning and development of Temescal Valley through our elected County supervisor and the Temescal Valley Municipal Advisory Council. Annexation would add another layer of government for Temescal Valley residents and we would lose representation.
- **WE BELIEVE** the city has historically annexed areas of the Temescal Valley when it was advantageous to do so for the purpose of commercial and residential development to increase its tax base. These random annexations have created unincorporated islands within Corona city boundaries, which are contrary to the Cortese-Knox-Hertzberg local government Reorganization Act.
- **WE BELIEVE** there are no services the city can provide that we now do not receive from the County. We fear new and additional fees charged by the city for the same services we now receive.
- **WE BELIEVE** our concern for our Temescal Valley neighbors, who do not reside within the city's sphere of influence, is justified. The level of county service they receive will be adversely affected if the annexation becomes reality. The annexation will create additional fringe communities, unincorporated islands and possible Disadvantaged Unincorporated Communities.
